Ranked 2 in D1 (home advantage), **Segers Johan**, against the winner of the match between the two 2nd placed ranked players in D2 group A & B, i.e. the winner of Pino Maurits against the loser of Yalçin Mahir against Steven Hoeylaerts (match 1)

Ranked 3 in D1 (home advantage), **van Dijke Paul**, against winner of D2 group A, **Van Herreweghen Toon** (match 2)

Ranked 4 in D1 (home advantage), **Van Middellem Guy**, against winner of D2 group B, i.e. the winner of Yalçin Mahir against Steven Hoeylaerts (match 3)

Semi-finals (best-of 3 to 13-point matches, 2-0 or 2-1):

Ranked 1 in D1 (home advantage), **Lamote Michel**, against winner of quarter-final match 3, ...

Winner of quarter-final match 1 (home advantage), ..., against winner of quarter-final match 2, ...

Final on Friday the 20th of December 2019 between these two winners (best-of-3 matches to 13 points, 2-0 or 2-1).

The BIC final is organized by BGFed.be (no home or away privilege in that case); winner of this final will be Belgian Individual Champion 2019.

A prize-giving ceremony will be held on the 20th of December, immediately after the end of the final.
